THE BROOKLYN BAR ASSOCIATION RAISES A FLAG FOR ITS 150TH CELEBRATION

The Brooklyn Bar Association celebrates its 150th anniversary in 2022 and to kick off the year it held a virtual flag raising ceremony recorded outside of its building on Wednesday, February 2.

"In many ways (the Brooklyn Bar Association) was born into a different world — the end of the Civil War, the end of slavery, was less than a decade old and Brooklyn was its own city, and the legal profession was mostly white and male," said Attorney General Letitia James, who spoke at the ceremony.

"Yet the mission of this bar association remains the same - you hold the legal profession and its members to the highest standards, you educate lawyers, you educate the public about lawyers and you fight for a more perfect union," James continued. "I applaud you for that mission and I join you in that fight."

The event was originally planned on being in-person, however, due to the recent outbreak of COVID-19, the BBA decided to host the event virtually. A little over 100 attorneys, including many local judges and many past presidents, joined other BBA members on Zoom to watch the event live.

"These are difficult times during a

pandemic," said Hon. Jeffrey Sunshine. "It has kept most of us out of the building physically, but we've adapted to a virtual world and so has the bar association. This too shall pass with the strength of this organization with the strength of this building, which Avery Okin tells me was purchased in 1928 from a sugar merchant."

Hon. Barry Kamins, the former administrative judge for the Supreme Court, Criminal Term, and a past president of the BBA, served as the master of ceremony. He introduced Father Patrick Keating, who performed the benediction, and then past presidents Hon. Miriam Cyrulnik and Hon. Jeffrey Sunshine, who both gave speeches that reflected on the association's history.

"Our association has a storied history, one that is shaped by its time," said Justice Cyrulnik. "In a collection of photos from the Brooklyn Historical Society, I came across photos of our annual dinners from the late 1940s and 1950. Not a woman in sight. Lawyers of color? No. How about lawyers under the age of 50? Apparently there weren't any. As society has thankfully evolved so have we as an institution.

"During the 40 years I have been a member, a committee chair, a trustee, an officer and a past president," Cyrulnik continued. "I have seen the Brooklyn Bar Association seek out and welcome the participation of women lawyers, lawyers of color, LGBTQ lawyers, young lawyers, lawyers of all backgrounds as we recognize the ability to serve our members, to serve the wider brooklyn legal community, and society as a whole is improved with the active participation of colleagues who have diverse experiences and backgrounds."

BEER TASTING EVENT

Since the flag raising ceremony was held as a virtual event there was no reception held after the ceremony. Instead, members of the BBA have organized a Beer Tasting on Monday, March 14.

Beer writer David Nilsen will guide BBA members through a 90-minute virtual tasting of six Belgian beer styles. During the tasting, Nilsen and the members will sample the six beers as he explains their history, their ingredients and the processes that make them each unique. He'll also discuss the history and modern variety of Belgian beers and how to best enjoy them.

"We wanted to come up with something fun that we thought the members would enjoy even virtually," said President-Elect Richard Klass. "This way we can still get together and reminisce about the history of the Brooklyn Bar Association and we can do it safely."
